AGM AGENDA: Constitution and Byelaws Modernisation.

As you will know from recent committee meeting minutes the clubs governance guidelines have been in need of update and modernisation and over the last several months the committee have been working hard in accomplishing this, so please see copies of the new drafts enclosed.

In general, the new versions have simply been rewritten and modernised but there are several inclusions and changes, all of which are recommended by the committee but which require appropriate AGM ratification.

To simplify proceedings at the AGM these changes are listed below for all to read in preparation before the AGM, and following a chance for discussion and if need be clarification at the AGM, the changes will be voted on in the usual way.

The enclosed drafts assume that the changes specified meet with membership approval, obviously if they do not then the necessary changes to the documents will be made prior to their being finalised.

Welfare:

With the correct modern focus being on the welfare of all members, the club are committed to meeting its responsibilities and, as can be seen in various sections of both the constitution and byelaws, the committee are recommending several changes as follows;

The creation of the post of Welfare Officer.

Changing the membership age groups and supervision requirements concerning junior members - based on NSPCC guidelines.

Highlighting the importance of parental responsibility.

Regarding more general changes, the committee recommends;

Changing the name of the Communications Officer to Online Secretary.

To increase the existing local boundary area (to incorporate those who live local to the club water at Bassingham) and also to include a secondary, slightly more extensive boundary, so as to prioritise more local applicants where possible (see enclosed maps and Constitution Sect 2c and d for clarification).

The use of prescribed, individualised application forms, available on request via email as and when the waiting list is open (Const. Sect 2b).

To modernise the clubs banking protocols (Const. 10a).

That all club trophies should be kept securely in the dedicated trophy cabinet (Byelaws F2).

To change the club's charity guidelines reflecting the views of many members who prefer to support more relevant causes (Byelaws E).

Routine AGM business:

The committee recommends;

That JB 1-3 shall be designated as members only pews and that night fishing shall not be allowed on this stretch.

That the annual renewal for qualifying seniors (those members who have reached 65 years of age and have been a full paying member for 10 years) should be raised to 50% of the adult rate. This will apply to those who join the club from 2025 and so obviously will not be relevant until 2035.

To allow night fishing on the entirety of The Fleet.

CONSTITUTION

“To promote and encourage angling across all disciplines, regardless of ability and social standing, and to provide, as far as is reasonably possible, a safe environment for all its members, recognising its responsibilities to vulnerable groups”.

The Association recognises its responsibility to safeguard the welfare of all vulnerable groups and aims to provide quality angling in a safe as practically possible environment by adopting the procedures in the clubs Welfare Policy (see annex....) and Health and Safety Policy (see annex....).

1) Name.

The Association shall be called The Collingham Angling Association (The Association).

2) Membership.

All members and applicants shall be classified into the following age groups at point of joining and/or renewal;

Juniors - 17 years old and under.

Intermediates - 18 - 20 years old.

Full paying adults - 21 and over.

Qualifying seniors (see 3d below).

a) There shall be a fixed number of full paying adult members, and the number shall be determined periodically at AGM as situations dictate, and all persons shall be eligible to apply.

b) As and when the waiting list is open, applicants may request, via email, an application form and shall fully complete, sign and return via the club's membership email address said prescribed application form.

c) Applicants whose primary address is within the immediate local boundary area (see boundary map annex ***) may apply at any time, and on approval, will be prioritised.

d) Those applicants whose primary address is outside of the immediate local boundary (annex ***) may only apply as and when the waiting list is open and, on approval, those whose primary address is within the secondary local boundary map (see annex ***) will be prioritised over those applicants whose primary address is beyond the local boundary areas.

e) Election to membership is at the discretion of the committee, no more than three committee members shall be absent when applications are being considered and three adverse votes serve as a rejection. On approval applications shall join the current waiting list.

cont....

f) If an application is unsuccessful they shall be disqualified from further application for a minimum of 12 months.

g) Successful applicants are required to pay a joining fee, determined periodically at AGM, and shall be disqualified from holding office for a period of 5 years from acceptance, although more recent members may be co-opted by committee should they possess relevant skill sets deemed to be beneficial to the Association.

h) Successful applicants shall be invited to join via the Associations Clubmate account.

i) Juniors may join via Clubmate at any time and shall not normally be required to join a waiting list, although this may be suspended from time to time at the committee's discretion.

j) Juniors may apply to upgrade to intermediate level upon reaching 18 years of age via email, shall be required to provide proof of age and, if accepted, will be subject to the increased subscription fee. No joining fee will be required.

k) Intermediates wishing to apply shall be subject to the same criteria as adult applicants (see 2b - 2h above).

l) The committee may elect any person as an honorary member of the Association for a period as they think fit and they shall be entitled to all the privileges of membership except that they shall not be entitled to vote at meetings, serve as an officer or on the committee.

3) Subscriptions.

a) Joining fees and subscriptions shall be fixed at AGM, following recommendations from the committee, and shall be due on joining and thereafter by the 16th June each year. A member who has not renewed by this date shall be deemed to have resigned.

b) Juniors shall not be required to pay joining fees and shall be eligible for discounted membership, determined periodically at AGM.

c) Intermediates shall be eligible for discounted joining fees and membership, determined periodically at AGM.

d) Members shall be eligible for discounted membership, determined periodically at AGM, once they have both reached 65 years of age and been a full paying member for a minimum of 10 years.

e) Existing members progressing through the classified age groups shall not be eligible for joining fees.

4) Disciplinary Procedure.

a) The committee shall have the power to expel a member when, in their opinion, it would not be in the interest of the association for him/her to remain a member. A member to be expelled is to be given 14 days written notice to attend a meeting of the committee to answer complaints made against them and shall not be expelled unless at least two thirds of the committee then present a vote in favour of his/her expulsion.

b) Any infringement of club rules and byelaws shall be dealt with as the committee sees fit in a fair and balanced manner. Any transgressors may be invited to attend a committee meeting to explain their actions.

5) Committee.

a) The committee shall be responsible for the management of the Association on behalf of the membership.

b) The committee shall have the power to enter into contracts and the sole right of appointing and determining the terms and conditions of service of employees of the Association.

c) The committee shall have the power to make, repeal and amend such byelaws as they may from time to time consider necessary for the well-being of the association. Byelaws which are repealed and or amended shall have effect until set aside by the committee or ratified at the next AGM.

d) Officers of the association shall serve for 12 months, must be proposed, seconded and elected annually at AGM and must be members of the club.

The Officers shall be eligible for the payment of honorariums out of the assets of the association to help elevate some of the expenses properly sustained by them in the management of the affairs of the Association. The amount is to be fixed annually at the AGM.

e) No member who has been disciplined by The Association shall be eligible to stand for office.

f) The members of the committee shall serve for 3 years, must be proposed, seconded and elected at AGM and must be members of the club.

The committee members shall be entitled to an indemnity out of the assets of the Association for all expenses and other liabilities properly incurred by them in the management of the affairs of the Association.

g) The committee shall consist of the following club officers and committee members;

President
Chairman
Vice Chair
Treasurer
Secretary
Online Secretary
Fisheries Officer
Asst Fisheries Officer
Match Secretary
Health and Safety Officer
Welfare Officer

9 committee posts, where possible to be filled by members from all angling disciplines. 3 to be elected each year.

h) Any retiree may re-apply at end of term and any mid-term casual vacancy may be temporarily filled by the committee up until the next AGM.

i) The Committee, if it thinks fit, may propose to elect at AGM Honorary Vice-Presidents. A Vice-president need not be a member of the Association, shall not be subject to re-election and shall not be eligible to attend committee meetings, although shall be allowed to attend and cast vote at AGM/EGM.

j) The committee may from time to time appoint from among their number such sub-committees as they may consider necessary and may delegate to them such powers and duties that the committee may determine. All sub-committees shall periodically report their proceedings to the committee and shall conduct their business in accordance with the direction of the committee.

k) Committee meetings shall, where possible, be held in the third week of each month and the quorum of that meeting shall be 10 members. The Chairman and the Secretary shall have discretion to call meetings of the committee if they consider it to be in the interest of the Association. The Secretary shall give all the members of the committee not less than two days' notice either orally or in writing of a meeting. Decisions of the committee shall be made by a simple majority and in the event of equality of votes the Chairman (or acting Chairman of that meeting) shall have a casting or additional vote. The Secretary, or in his/her absence a member of the committee, shall take the minutes and once adopted shall be available on The Associations secure website and the Millenium Lodge notice board.

6) Annual General Meeting (AGM).

The Annual General Meeting of the Association shall be held each year not later than 16th May to transact the following business:

- a) To receive the Chairman's report of the activities of the Association during the previous year.
- b) To receive, consider and adopt the accounts of the Association for the previous year, the auditor's report on the accounts and the Treasurer's report as to the financial position of the Association.
- c) To receive the Match Secretary's, Fisheries Officer's and Online Secretary's reports for the previous and forthcoming year.
- d) To remove and elect the auditor or confirm that he/she remains in office.
- e) To remove and elect the officers.
- f) To remove and elect members of the committee.
- g) To decide on any resolution that may be duly submitted within the time frame given below.
- h) Nominations for the election of members to any office or for membership of the committee which have been duly proposed and seconded must be submitted to the Secretary not less than 28 days prior to the AGM.
- i) Any resolutions proposed to be moved at the AGM must be submitted to either the Online Secretary or Chairman not less than 28 days prior to the AGM.
- j) The AGM agenda, complete with resolutions from members and recommendations from the committee, is to be available on request to all members 14 days prior to the meeting.

7) Extraordinary General Meeting.

An Extraordinary General Meeting (EGM) may be called at any time by the committee, and shall be called within 28 days of receipt by the Online Secretary of a request in writing signed by not less than twelve members stating the purposes for which the meeting is required and the resolutions proposed. The requisition shall be accompanied by a fee which may from time to time be fixed by the AGM and may in some instances be refunded.

8) Procedure at the Annual / Extraordinary General Meeting.

a) The date of the AGM is to be fixed annually and due notice shall be given by way of The Associations website. In addition, notice for AGM/EGM is to be given on the Millennium Complex notice board.

b) The quorum for AGM / EGM shall be 20 members.

c) The Chairman, or in their absence a member selected by the committee, shall take the chair.

d) Each member present shall have one vote and resolutions shall be passed by a simple majority. In the event of an equality of votes the Chairman shall have a casting or additional vote.

e) The Secretary or in their absence, a member of the committee, shall take the minutes at the AGM / EGM, and once approved shall be adopted, via email, from no less than 20 AGM attendees. Once adopted they shall be available from The Associations secure website, and on the Millenium Lodge notice board.

9) Rules and Byelaws.

a) The rules may be altered by resolution at AGM / EGM provided a two thirds majority is obtained.

b) The Committee shall have the power to make, repeal and amend such byelaws as they may from time to time consider necessary for the well-being of the association. Byelaws which are repealed and or amended shall have effect until set aside by the committee or at an Annual General Meeting.

10) Finance.

a) All monies payable to the Association shall be deposited into the Associations current bank account in the name of the Association.

The current account shall retain a quantity of working capital, amount determined periodically by the committee, and shall be accessible to the treasurer for the day to day running of the Association.

Any capital above this amount shall be deposited, by the treasurer, into the Association's capital reserve business account until required. Withdrawals from the business account shall be via bank mandate, deposited into the current account and require the input of no fewer than 2 signatories, who shall be the President, Chairman, Secretary, Treasurer or any Trustee. For large withdrawals, the amount to be determined periodically by committee, no fewer than 3 signatories shall be required.

Any monies not required for immediate use may be invested as the committee, in their discretion, think fit.

cont....

b) The income and property of the association shall be applied only in the furtherance of the objects of the Association and no part thereof shall be paid by the way of bonus, dividend or profit to any members of the association, save as set out in paragraphs 5d and 5f.

c) The financial transactions of the Association shall be recorded solely by the Treasurer both responsibly and in a fit and proper manner.

d) The committee shall have power to authorise the payment of remuneration and expenses to any officer, member or employee of the Association and to any other persons for service rendered to the association.

11) Trustees.

The Chairman is nominated as a person to appoint new trustees within the meaning of Section 36 of the Trustee Act 1925. A new trustee shall be nominated by resolution of the committee and the Chairman shall by Deed duly appoint the person or the persons so nominated by the committee as the new trustee or trustees of the association and in the provision of the Trustee Act 1925 shall apply to any such appointment shall in favour of a person dealing bona fide with the association or the committee be conclusive evidence of the fact so stand.

12) Borrowing.

a) The committee may borrow money on behalf of the association for the purpose of the association, at their own discretion, for the general up keep of the association or with the sanction of a General Meeting for any other expenditure, additions and improvements.

b) When borrowing, the committee shall have the power to raise in anyway any sum or sums of money in such manner or on such terms and conditions as they think fit and in particular by mortgage or of charge upon or by the issues of debentures charged upon all or part of the property of the association.

c) The committee shall have no power to pledge the personal liability of members of the association for the repayment of any sums so borrowed.

d) The trustees shall, at the discretion of the committee, make such dispositions of the association property, or any part thereof, and may deem property acceptable for giving security for such monies and the interest payable thereof.

13) Property.

- a) The property of the Association, other than cash at the bank, shall be vested in not less than two and no more than four trustees. They shall hold the property upon Trust for the members of the association in accordance with the directions of the committee.
- b) The trustees shall deal with the property as directed by resolution of the committee and entry in the minute book shall be conclusive evidence of such a resolution of the committee.
- c) The trustees shall be elected by the committee of the association and shall hold office until death or resignation unless removed by a resolution of the committee.

14) Dissolution.

- a) A resolution to dissolve the Association shall only be proposed at an EGM and shall be carried by a majority of at least three quarters of the members present.
- b) The dissolution shall take effect from the date of the resolution and the members of the committee shall be responsible for the winding-up of the assets and liability of the Association.
- c) Any property remaining after the discharge of the debts and liabilities of the Association shall be given to a charity or charities nominated by the last committee.

Byelaws

“To promote and encourage angling across all disciplines, regardless of ability and social standing, and to provide, as far as is reasonably possible, a safe environment for all members, recognising its responsibilities to vulnerable groups”.

It is incumbent on all members to behave appropriately and be considerate and respectful of both other anglers and the fishery itself, and to uphold the standards of The Association at all times.

The committee shall have the power to make, repeal and amend such byelaws as they may from time to time consider it necessary for the well-being of the association. Byelaws which are repealed and or amended shall have effect until set aside by the committee or ratified at an Annual General Meeting.

A) Clubwaters

Collingham Angling Association controls the following waters.

a. River Trent - Collingham – from Cromwell Weir downstream on east bank to Collingham parish boundary omitting 2 short stretches (separated by 3 association pegs) at The Jolly Barge. Access via Westfield Lane for Weir field or via Carlton Ferry Lane (Trent Lane).

BRITISH WATER WAYS Strongly advise no fishing from boats in the weir area.

b. River Witham - Bassingham – Left bank downstream between footbridge and road bridge and 1 field left bank downstream of roadbridge. Access via footpath near church downstream and road bridge upstream and downstream.

c. River Fleet – East bank for 2 fields, situated between Besthorpe and Girton, access via Tinkers Lane off A1133 Gainsborough Road.

d. Millennium Complex, Spalford – Access via gates from Wigsley Road (A key for the gate may be obtained from the committee).

With the exception of the Millennium Complex, club waters will be closed during the coarse fish close season. Association members holding a Salmon and Sea Trout licence may fish for migratory fish on the River Trent during this period in accordance with E.A. byelaws.

All anglers fishing association waters MUST hold the appropriate current EA rod licence(s).

B) Contact Details.

C) Welfare.

The Association recognises its responsibility to safeguard the welfare of all vulnerable groups and aims to provide quality angling in a safe as practically possible environment by adopting the procedures in the clubs welfare policy (see Constitution annex....).

D) Membership.

1) Membership Categories;

Juniors: 17 years old and under.

Intermediates : 18 - 20 years old.

Adults : 21 years old and above.

Qualifying seniors - see constitution sect. 3b.

2) It is the responsibility of all members, and the parents or guardians of junior members, to read and understand all the Associations' byelaws prior to arrival at club waters and to ensure that they are adhered to at all times.

3) In regard to junior members aged 12 and over parents/guardians must use their judgment, based on the child's maturity and readiness, as to whether they should be left unsupervised, and provided that the child feels safe, prepared, and mature enough to handle emergencies. In any event junior members aged under 12 must be supervised at all times, and ALL junior members must be supervised between sunset and sunrise (see sect.8 below).

E) Charities.

Collingham Angling Association facilitates several charity matches across its waters annually. Any monies raised will be distributed as the committee sees fit, where possible to charities local to Collingham and/or when pertinent to membership suggestion. All members may submit a charity for consideration.

F) Club matches.

1) All matches shall be fished according to the Angling Trust match rule guidelines in conjunction with the Association's venue specific rules (see below).

2) All club trophies shall be kept in the trophy cabinet located at Collingham Football Club. Replicas are available on request.

G) General Byelaws.

1) Membership cards must be carried at all times!.

2) No Litter!. Site bins are not for anglers rubbish - if you have brought it with you then take it home!.

3) No fires - Small scale self-enclosed Bar-B-Qs are allowed but care must be taken not to spoil neither other angler's enjoyment nor the environment.

4) Facilities - With the exception of the toilets situated in the fishing lodge at The Millenium Complex there are no toilet facilities. Members fishing on association water are to make sufficient provisions for the duration of their visit. Any member caught defecating on association property will be expelled.

5) All matters relating to Association business shall be confined within the membership. Any member found divulging the same to non-members will be expelled.

6) No fish to be removed or transferred to, from, or between Association waters without the express consent in writing from the committee.

7) Guest Passes;

a) Members are permitted to invite one guest to accompany them on club waters at the Millennium Complex and on the association river stretches, the cost of which will be fixed from time to time by the committee and ratified at AGM. See 27 and 39 below.

b) Members are permitted 2 guest passes per season per venue and individual guests are only permitted twice per season per venue.

8) Juniors;

a) No junior member under 12 to be unsupervised at any time.

b) All junior members to be supervised between sunset and sunrise (see below).

c) Any person supervising juniors must fish either together or in adjacent pegs.

d) Intermediate members may supervise junior members but strictly on a one-to-one basis only. Adults may supervise up to 2 juniors, those adults who are not members are not permitted to fish, unless on a guest pass.

e) Should a junior member wish to be supervised between sunset and sunrise by an adult who is not a member, then the club must be notified via email in advance, stating their name and membership number together with the name and address of the supervising adult and a contact phone number.

- 9) Members shall not;
- a) Damage fences, leave litter, illegally remove fish or wilfully disturb or kill any game.
 - b) Wilfully alter, deface or in any way disturb any notices erected in respect of club business,
- 10) Members must behave respectfully at all times and shall not cause an affray, use excessive bad language in a threatening manner, make derogatory remarks to another member in person and/or on social media **nor bring the association into disrepute in any way.**
- 11) Any transgressions may result in expulsion from the Association or result in any such lesser punishment as deemed appropriate by the committee. Minor infringements, in the judgement of committee members, may be subject to a '3 strikes and you are out' policy. Any member expelled shall not be eligible for any subscription refund and shall not be eligible to re-apply for membership.**

Millennium Complex Byelaws.

Please take ALL litter home!.

- 12) The gates to the complex are to be kept locked at all times and there is a strict 10mph speed limit in force.
- 13) Barbless hooks only, the exception being barbed hooks for pike and lure fishing.
- 14) No braided mainlines, with the exception of lure fishing and spod or marker rods.
- 15) Night fishing is only permitted in Kestrel, Kingfisher and Swan Lakes.
- 16) No matches to be held other than those given express permission by the committee. Association bye-laws and match rules apply in all cases.
- 17) Parking only in the areas designated and to be in an orderly manner. No racing of motor vehicles within the complex. Local rules will apply to take in account weather and local conditions.
- 18) No Keep-nets on millennium complex save for committee approved matches and/or fishery management business.
- 19) No unattended rods.
- 20) Any dog on the complex must be on a lead at all times and under the owner's control.

- 21) All fishing on Willow and Centenary to be from nominated platforms.
- 22) Only one rod permitted to be used at any one time in Willow and Centenary Lakes with the exception of pike fishing.
- 23) All fish that are weighed to be weighed in approved weigh slings.
- 24) All pike caught on Willow or Centenary lakes must NOT be returned but placed in Kingfisher or Kestrel.
- 25) No fish are to be brought on to the complex and put into any of the lakes without the relevant health and movement licenses or certificates, and CAA committee approval.
- 26) No Motorhomes or Caravans allowed on the Millennium complex overnight.
- 27) There are 2 guest tickets available for the use of members who wish to invite a guest to fish with them on the club's water at Spalford (see 7 above). Tickets are available for either sunrise to sunset or for 24 hours, must be reserved through the club secretary and are payable at the time of booking.

The club secretary will record the name of the member and full details of the guest. The member and guest must fish in adjacent pegs and the member shall be responsible for ensuring that the guest complies with the Club's rules applicable to a member. Failure to do so will result in the member being required to attend before the Committee to show just cause why he/she should not be expelled from Association.

Kestrel, Kingfisher and Swan Lakes.

These rules apply to anglers fishing for specimen carp.

- 28) All anglers should carry a landing net of 36 inches minimum, suitable for specimen fish. A good quality unhooking mat and a Carp-Care Kit should also be carried at all times.
- 29) Minimum of 12lb main line with a maximum of 1 meter leader.
- 30) No bolt rigs, the fish must be able to eject the lead, should the line break at any point.
- 31) Fishing from designated pegs only.
- 32) No sacking of fish, fish may be kept in a floatation device for up to 1 hour.
- 33) Bait boats must be operated from the peg you are fishing, must only travel in a straight line until hook-length is dropped and must not cross lily pads nor weed lines. Hook-lengths must only be dropped to an area where an angler can safely cast to.

River Trent & Fleet Byelaws

Please take ALL litter home!.

The following stretches of the River Trent are designated as members only pegs;

W1a - W4 - for the first 7 days of every month.

Pegs P1 - P15 - except when required for large scale external match bookings (P74 - 80).

JB1 - 3.

Downstream from Carlton Ferry Lane to the end of the club's stretch (the CF's).

34) Temporary memberships for the Fleet and Trent may be obtained on the bank, issued by the river bailiffs. No temporary memberships will be issued on any of the stretches allocated as private pegs. Prices will be set from time to time by the committee and ratified at AGM.

35) Temporary memberships will be valid from sunrise to sunset on the day of issue utilising the official times displayed on the Collingham Angling Association web page.

36) All temporary members must be clear from Collingham Association waters and land 30 minutes after sunset and will not be allowed on until 30 minutes prior to sunrise. This includes car parks and tracks along the flood banks over which the association has authority.

37) Night fishing is allowed for association members only on both The Trent and The Fleet (see exclusions-38 below).

38) No night fishing will be allowed for any reason on Trent Pegs W1a to W4 nor JB1 to 3.

39) There are 2 guest tickets available for the use of members who wish to invite a guest to fish with them on the club's water on the River Trent and on the club's property (through the gate/South end) of the River Fleet (see 7 above). Tickets are valid for a maximum of 24 hours, must be reserved in advance through the river bailiff, and are payable at the time of booking.

The river bailiff will record the name of the member and full details of the guest.

The member and guest must fish in adjacent pegs and the member shall be responsible for ensuring that the guest complies with the Club's rules applicable to a member. Failure to do so will result in the member being required to attend before the Committee to show just cause why he/she should not be expelled from the Association.

40) No guest tickets will be issued on any of the stretches allocated as members only pegs.

41) Pegs W1a to W4 are to be booked in advance through the river bailiff and are to be paid in advance. The river bailiff will record the name of the member and full details of the member.

42) No member or temporary member shall fish from the wall at Cromwell Weir. Anyone found doing so will be immediately expelled.
